Dear O*NET Beta Developer:

The attached information is being provided as an update to developers regarding unpublished Dictionary of Occupational Titles (DOT) codes and titles. Subsequent to the publication of the 1991 Revised Fourth Edition DOT, new data were analyzed for 23 occupations. These additional occupations were used, along with all other DOT occupations, in the development of O*NET occupations and ratings. In the O*NET 98 Beta, these DOT occupations are crosswalked to O*NET occupations. They are not, however, linked to the other occupational classification systems included in the R&D Viewer.

Full descriptions and underlying data for these occupations can be downloaded via a special password protected Web site that has been set up for developers. To access this site, connect your browser to "http://www.trefoil.com/developers/". When downloading these data files, use "dev" as the username and "jh49q" as the password. This special Web site will also be used to keep beta developers informed of various O*NET related developments, so it is recommended that you check this Web site on a regular basis over the next several months.

Occupational analysis conducted subsequent to the last publication of the Dictionary of Occupational Titles resulted in the development of descriptions and codes for 23 occupations not appearing in the DOT Fourth Edition, Revised 1991. These occupations were used, along with all other DOT occupations, in the development of O*NET occupations and ratings. In O*NET 98, these DOT occupations are crosswalked to O*NET occupations. They are not, however, linked to occupations in the other seven classification systems included in the Viewer.
